## WHAT IS A FILIBUSTER?

Because filibusters are in the news, you may want to know more about filibusters. The word filibuster comes from "filibusteros," an old word for pirates. A filibuster is basically an extended debate in the Senate, which has the effect of preventing a vote, since a vote can only occur after a debate ends. It is used exclusively in the Senate because (unlike the House) Senate rules contain no motion to force a vote. Individual Senators filibuster simply by refusing to

yield the floor--essentially, they just continue to talk about whatever they can for as long as they can. A filibuster can be ended by a two-thirds majority vote called a "cloture."

This is a good quick overview of the history of the word "filibuster." It is in point-form and includes two mildly comical illustrations.

## UPDATE ON PATRIOT ACT

The House of Representatives on Nov. 20 voted 264 affirmative and 163 against to approve the conference report on fiscal 2004's budget for U.S. intelligence agencies reported at approx. \$40 billion. HR 2417 drew criticism over its expansion of federal investigative powers in terrorism probes. It broadens the definition of businesses whose records can be seized without a court order. Local legislators voting for HR 2417 include: Lewis, Calvert, Bono, and Issa. Voting no: Baca.



Meanwhile back at the ranch Attorney General Ashcroft marked the two-year anniversary of the terrorist attacks of September 11 by launching a national publicity tour to sell Americans on the USA Patriot Act. The act is already law, and when it came to a vote just six weeks after the 9/11 attacks only a single senator, Russell Feingold, and sixty-six members of the House voted against it.

Ashcroft's national tour will not address the public. His speaking engagements are all before closed audiences, primarily law-enforcement officers. The Foreign Intelligence Surveillance Act (FISA), greatly expanded by the Patriot Act, allows the government to conduct secret searches of "foreign agents" in criminal investigations without establishing probable cause of criminal activity, which the Fourth amendment generally requires before a warrant can be issued. The ACLU and the Center for Constitutional Rights recently filed lawsuits challenging the constitutionality of parts of the act, and the February leak of a Justice Department draft of "Patriot Act II" led to widespread criticism.
